# MESSAGE FROM LLID CHAIR - DAVID HILBER

WE NEED YOU. As the Lida Lakes Improvement District (LLID) approaches the end of its fourth year, for the first time, we will be electing new board members. We need volunteers to step forward, to put your name up for election as a board member, to play a role in the future of the LLID. This is the last year that Sheldon Poss and I can serve on our board per our bylaws. So, we need at least two LLID members to run for the board. One resident (year-round) and one seasonal. Being a board member is not time consuming. We hold 5 board meetings each year, with occasional email or in person discussions depending on projects we are addressing. In this newsletter you will see what we have been doing this year, including over \$10K of walleye stocking in North and South Lida, survey and treatment of Curly-Leaf Pondweed on both lakes (aided this year by a \$5.5K grant from the MN DNR), and a pending grant request for \$57K to aid in performing a comprehensive lake-shed assessment of our lakes. Please step forward and take an active part in protecting and caring for our beautiful lakes.


# NEW BOARD MEMBERS WANTED!

# LAKE COORDINATOR REPORT - MORIYA RUFER

I am happy to report we are optimistic for the Lida Lakes heading into 2025. The Lida Lake Property Owners Association applied for a grant from the Minnesota Board of Water and Soil Resources (BWSR) in January. This grant was available to non-profit organizations to study and improve water quality. The funds come from the state's Clean Water Land and Legacy Amendment funds (https://www.legacy.mn.gov/clean-water-fund). We should hear back about the grant by the end of March. If we are awarded the funding, the LLPOA and Lida Lakes Improvement District would complete a comprehensive study to identify risks to the lake and sources of nutrients that can affect water quality. We would then identify projects that can be

implemented to improve the lake. In June of 2024 we completed an aquatic plant survey to document invasive curly-leaf pondweed at its peak growth. We identified curly-leaf pondweed in both North and South Lida Lakes. These areas will be targeted for herbicide treatment this May. The treatment date will depend on ice out timing and weather. We will keep you updated when we have a potential date. We also received a grant for \$5,500 from the DNR to offset some of the treatment costs in South Lida. Happy Spring!


## LAKE MANAGEMENT COMMITEE REPORT - BRIAN GRAFTAAS



The Lake Management Committee meets monthly and consists of myself, Dee Dee Stephenson, Zach Herrmann, and Lake Coordinator Moriya Rufer. Moriya has been a great addition this past year as she brings a wealth of knowledge and has been key for the Lake Improvement District in applying and acquiring grants. Clean Water project: I have great news! After two years of delays, the Clean Water project that the LLID was helping fund in Moonlight Bay was completed in November 2024. This was a major source of phosphorous entering South Lida. This project was funded by the West Ottertail County Soil & Water Conservation District (SWCD), Lida Township, the landowner, and the LLID. We had originally allocated \$3,000 to this project, but the SWCD ended up funding a larger percentage of the

project, bringing our costs down to \$1,233. We are pleased with the results, and are open to doing other Clean Water project with the SWCD in the future. Keep it Clean: the LLID participated in the Keep It Clean initiative (https://keepitcleanmn.org) for the second year. The Keep It Clean campaign addresses the growing problem of garbage and waste left on the ice by anglers and campers through education, legislation and enforcement. The Keep It Clean bill was signed into law in May 2023, making it illegal to place garbage and waste on or under the ice on Minnesota's lakes and rivers. The LLID had signs posted at the main access on North Lida and at Iry's Landing on South Lida. In addition to having posters at the Ice Hole bar and area bait shops. CLP Treatment: We're planning to treat for Curly-Leaf Pondweed (CLP) again this year; however, we are going to be using a

different aquatic herbicide than we have used in the past. We've always used Aquathol K in previous years, which is very expensive but it targets CLP and does not harm native plants or the fish population. We have considered other herbicides in the past; however, chose against them because they would kill native plants - not just the CLP. There is a new chemical available, Flumioxazin, which is also targeting to CLP, and is cheaper than Aquathol K. The University of Minnesota has tested Flumioxazin and found it be be effective for treating CLP, but would not harm native plants or the fish population. The DNR has also supported the use of Flumioxazin as a treatment of CLP. Also, we got a \$5,500 grant to help cover the cost of CLP treatment. We will be posting information about the areas treated on the website later this spring.

### FISHING COMMITTEE REPORT - MIKE SPANGLER, CHAIR

On October 11th, LLID stocked a total of 816 lbs. of walleve fingerlings (4"- 6") into North and South Lida Lakes. North Lida received 571 lbs. (17,136 fingerlings) and South Lida received 245 lbs. (7,344 fingerlings). In October and November, MN DNR stocked a total of 1319 lbs. of carry-over walleye (2 per pound). North Lida received 900 lbs. (1800 walleye) and South Lida received 419 lbs. (838 walleye). Beginning in 2025 the DNR proposed and approved a more aggressive lake management stocking plan.

North Lida: Stock walleye fry at a rate of 1,000 per littoral acre (2,380,000) on an annual basis for 3 years (2025, 2026, 2027). [Note: DNR stocked 500 walleye fry per littoral acre (1,190,000) for 3 years (2019, 2021, 2023).] The DNR has also designated North Lida Lake as a Carry-over Walleye Surplus Lake and will be doing additional stocking up to 1 lb. per littoral acre or 2,380 pounds of walleye for the duration of annual fry stocking.

South Lida: Stock carry-over walleye or large fingerlings at a rate of 1 lbs. per littoral acre (356 lbs.) on an annual basis for 3 years (2025, 2026, 2027). [Note: DNR stocked 500 walleye fry per littoral acre (178,000) for 3 years (2019, 2021, 2023).] The DNR has also designated South Lida Lake as a Carry-over Walleye Surplus Lake and will be doing additional stocking up to 2 lbs. per littoral acre or 712 pounds of walleve for the duration of annual large fingerling stocking. DNR will continue to conduct annual fall walleye electrofishing and plans to survey North & South Lida David Boe caught and released a again in 2027.

#### LLID'S FUTURE DEPENDS ON YOU!

Lida Lakes Improvement District is operated by property owners like you. Serving on the Board of Directors or Committees is important for the betterment of our lake. Two board positions will be up for election at the August 2025 annual meeting. Committees are also expanding. Are you interested in serving? As required by MN Statute 103B.551, a majority of the board members must be residents of the LLID. With a 7-member board, 4 board members are residents of the lake and 3 are seasonal property owners. This year, 1 board seat for a resident member and 1 seat for seasonal residents will be on the ballot. The LLID will provide ballots for mail-in voting a minimum of 8-weeks ahead of the 2025 Annual Meeting. Due to logistics of developing packets for mailing, we require all candidates, including those up for re-election notify the LLID Board of Directors prior to the next board meeting April 26, 2025. A write-in option will also be available for candidates that decide to run after the April 26, 2025, deadline. *If you are interested in serving of the Board of Directors and would like your name included on the ballot, please email lakelidalid@gmail.com before April 25, 2025.
